CONDITIONS OF SALE

We invite you to join us in supporting HCP's mission by attending our 2017 Print Auction. If you are unable to attend the night's festivities, you may either place an absentee bid online or fill out an absentee bid form and either fax or mail your form to HCP. Please visit www.hcponline.org to purchase tickets, become a 2017 Auction sponsor or to fill out your absentee bid.

- 1. Photographs will be offered for sale in the same order in which they are listed in the printed catalog. Any work received and accepted into the auction after press time will be listed in an addendum available at the opening reception, exhibiton and auction.
2. Bids will only be accepted from registered bidders and absentee bidders who leave written or order bids with HCP in advance of the auction. Bid numbers will be available at the registration desk on the day of the auction.
3. Absentee bids will be accepted by mail, telephone, fax, or in person until 6:00 p.m. on Tuesday, February 17 at 6 p.m. Absentee bid forms can be found on the website at www.hcponline.org or in person at the HCP galleries. Such bids will be executed at the lowest possible price, subject to the reserve price and other bids. If two or more parties have entered matching bids, the earliest bid received shall take preference. Notification of successful bids will be made within seven working days of the auction.
4. The highest bidder acknowledged by the auctioneer shall be the buyer. The auctioneer has the right to reject any bid and to advance the bidding at his absolute discretion. Should there be any dispute after the sale, the auctioneer's record of the sale shall be conclusive. On the fall of the Auctioneer's gavel, title to the offered lot shall pass to the buyer, who shall assume full risk and responsibility for the purchase price. If the buyer fails to comply with any such requirement, the lot may, at the Auctioneer's discretion, be put up again and sold.
5. If the Auctioneer decides that any opening bid is below the value of the lot offered, he may reject the bid and withdraw the lot from the sale.
6. All lots are sold "as is". All purchases made the night of the Auction are final. We make no representation as to the condition of any lot sold and no reference to imperfection is made in the catalog description. Prospective purchasers (or their designated representatives) should personally view lots offered for sale to evaluate their condition.
7. Estimates are furnished only as a service to prospective bidders. They signify the retail value of each lot. These estimates have been prepared well in advance and are subject to change.
8. Unless a lot is identified as part of a limited edition, no edition limit should be assumed.
9. Payment is due on the evening of sale. Cash, personal check (with proper identification), American Express, VISA, or MasterCard are accepted. Credit card sales will be executed the day of the Auction. Purchases to be shipped will be professionally packed and sent via U.S. mail or UPS Ground. Buyer agrees to cover 3rd party shipping charges from HCP to buyer's destination, plus \$25 in packaging and handling charges.
